Thank you for your interest in participating as a Food Truck Vendor for the City of Mary Esther Veterans Day Parade! This year's event will take place on Friday, November 11, from 11:00 AM to 3:00 PM. ## GENERAL INFORMATION

- Food Truck Vendor shall take the proper safety and health precautions to protect patrons, the City, the public, and the property of others. Vendor shall be responsible for all damage to persons and/or property that occur as a result of the vendor's negligence or misconduct.
- Food Truck Vendor is required to supply their own supplies needed for set up. Water and electricity hook-ups are not available.
- Food Truck Vendor agrees to comply with any and all applicable Federal, State, County, and City laws and regulations and to post proof of all necessary licenses in its booth.
- Food Truck Vendor agrees to serve from 11:00 am - 3:00 pm. Setup shall be completed between 9:00 am - 10:30 am. Late arrival may result in space being unavailable. Leaving early could result in cancellation of future events.
- Food Truck Vendor agrees to keep their space attractive and to clean them when the event ends. All litter, cardboard boxes, product debris, crates, boxes, etc., must be removed at the close of the event.
- Food Truck Vendor understands that alcoholic beverages may not be sold or consumed at the event.
- Food Truck Vendor consents to the City of Mary Esther, its employees, agents, or volunteers capturing photography, audio, video and using content in future promotional materials.

## APPLICATION INSTRUCTIONS

- 1) Applications will be accepted on a first-come, first-served basis.
- 2) All applications will be reviewed by City of Mary Esther staff, which has the full authority to approve or deny participation in the event.
- 3) The City of Mary Esther reserves the right to restrict the type and number of vendors, and to select vendors who best meet the needs of the event.
- 4) A complete application packet is required, including the following:
  - a. Application form
  - b. Copy of the vendor's food service license
  - c. Certificate of insurance, with City of Mary Esther and SRM-SPE LLC listed as additional insured
  - d. Photo(s) of the food truck
